

LIMITED LIFETIME WARRANTY

Zastava Arms USA hereby provides the following LIMITED LIFETIME WARRANTY, to the original purchaser of the enclosed Zastava Arms firearm subject to the terms and conditions set forth below. THIS IS THE ONLY WARRANTY EXTENDED BY ZASTAVA ARMS USA COVERING THIS FIREARM.

What does the warranty cover and what is its duration?

Zastava Arms USA warrants to the original purchaser that the enclosed firearm was made free of defects in material, function, and workmanship. Zastava Arms USA promises to remedy any defect in material, function or workmanship for the entire time that the original purchaser owns the firearm. This warranty covers the firearm's receiver, bolt carrier, bolt, firing control group, pins, pin retainers and rivets on ZPAP AND M91 models imported by Zastava Arms USA. This warranty terminates automatically upon the transfer of this firearm to any individual or entity other than the original purchaser.

For avoidance of doubt, this warranty does not apply to or cover any defects associated with any on-gun, or off-gun, part or accessory that is included with your firearm that (a) is capable of being readily detached and, or, replaced, (b) bears the name of a brand other than Zastava Arms USA, or (c) includes any glass or electronic component.

Disclaimer and Limitation of Remedy.

ANY IMPLIED WARRANTIES OF MERCHANTABILITY IMPARTED BY STATE LAW WILL BE LIMITED TO ONE (1) YEAR. Some States do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

ZASTAVA ARMS USA EXCLUDES AND WILL NOT PAY INCIDENTAL OR CONSEQUENTIAL DAMAGES UNDER THIS WARRANTY. INCIDENTAL OR CONSEQUENTIAL DAMAGE MEANS ANY LOSS, EXPENSE, OR OTHER DAMAGE THAT CANNOT BE REMEDIED BY EITHER REPAIRING ANY DEFECT IN THE FIREARM OR BY REPLACING THE FIREARM.

Some States do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This LIMITED LIFETIME WARRANTY gives you specific legal rights, and you may also have other rights which vary from State to State.

Zastava Arms USA will not be responsible for:

- 1. Failure to provide proper care and maintenance,
- 2. Accidents, abuse, or misuse,
- 3. Barrel obstruction,
- 4. Hand loaded, reloaded, or improper ammunition,
- 5. Unauthorized adjustments, repairs, or modifications, or
- 6. Normal wear and tear.

How do you obtain warranty service?
